PT MRT Jakarta (Perseroda), with the support of the Government of Indonesia and development partners, invites all interested international and domestic bidders to participate in a Market Sounding Event related to the Jakarta Metropolitan Mass Rapid Transit East-West Line Phase 1 Stage 1 Project.

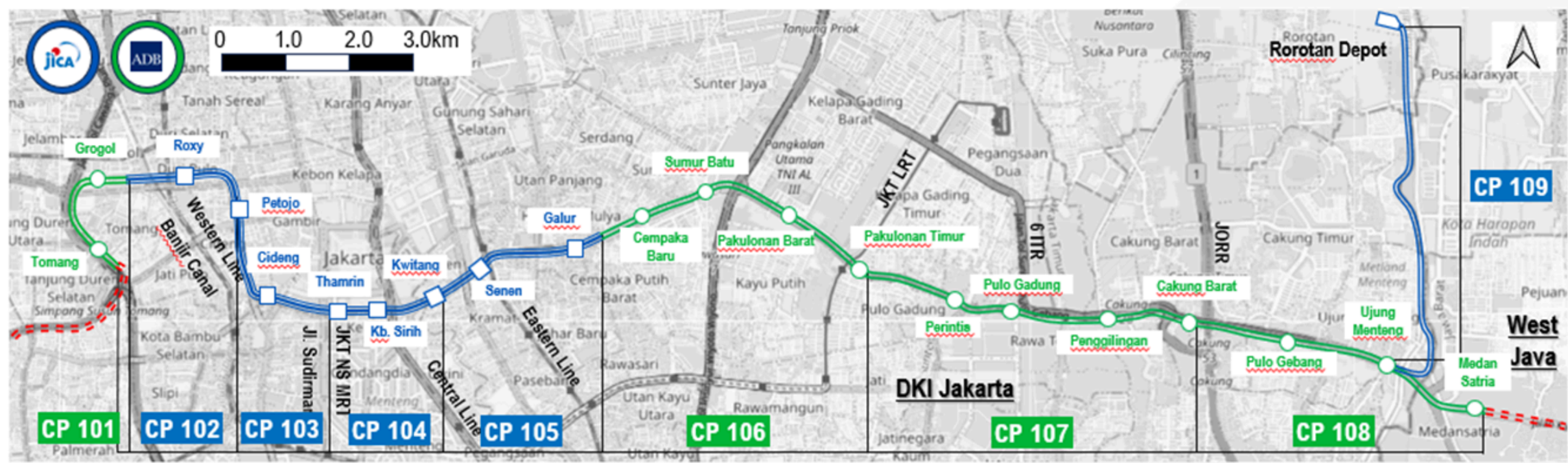
Jakarta Metropolitan Mass Rapid Transit East-West Line Phase 1 Stage 1 Project is intended to be jointly financed by the Asian Development Bank (ADB), Japan International Corporation Agency (JICA) and the Government of Indonesia.

This Market Sounding Event specifically focused on the scope financed by the ADB.



Project Overview

The Project involves the development of a mass rapid transit (MRT) with approximately 24.5 km Main Line from Tomang Station to Medan Satria Station consisting of 8 underground stations and 13 elevated stations and a Main Depot Facility at Rorotan including a 5.9 km Depot Access Line from Ujung Menteng Station, aimed to meet the increasing transportation demand and enhance public transportation in the Jakarta metropolitan area.

JICA will finance the civil works of the underground sections from Grogol to Cempaka Baru for 8.6 km, 8 underground stations, elevated depot access and system components, track works and rolling stocks. ADB will finance civil works for the elevated sections between Tomang and Grogol and between Cempaka Baru and Medan Satria, totaling 15.9 km, including 13 elevated stations along these sections.

OBJECTIVES

- ✓ Provide an overview of the project scope, indicative procurement strategy, and anticipated civil works packages for elevated sections where ADB finance will be applicable;
- ✓ Provide further information on the elevated civil works package;
- ✓ Gather feedback from industry participants on market capacity, technical and administrative/qualification considerations, and procurement approaches, among others;
- ✓ Promote fair and open competition in line with ADB's Procurement Directive (2026, as amended from time to time).

- ✓ Interested participants should register no later than **30 January 2026, 05.00 PM Jakarta Time.**
- ✓ The company intending to attend in person may nominate not more than two (2) participants. Likewise, the company which intends to attend online shall have a maximum of two (2) participants. In case a company intends to attend online and in person, the number of participants attending with both modes of attendance is limited to two (2) participants each mode, subject to quota availability.
- ✓ Notification and confirmation including the details of the time and the venue shall be sent to successful registrants to their registered e-mail addresses after the registration is closed no later than **03 February 2026.**
- ✓ Due to the capacity of the event venue, only a limited number of companies will be accepted. Each company intending to attend offline **(including, but not limited to, the same company registered in different countries, subsidiary companies, or affiliated entities)** shall be limited to one response form.
